Who is eligible for free legal help?

Federal regulations determine which low income residents of San Diego County are eligible for free legal services. Call to find out if you are eligible:

What should you do if you need legal help?

If you are eligible for free services, you will receive assistance immediately from our hotline staff and/or be given an appointment to meet with a legal worker. If we cannot help you, we will refer you to another agency.

When should you contact us?

Call us as soon as you know there is a problem or crisis. The sooner you call, the more likely it is that we can help you.

Why should you call us?

Our staff of expert legal workers will help you resolve your legal needs *free of charge*.
